STILES TOWN BOARD MONTHLY MEETING - TUESDAY, JUNE 8, 2021

Stiles Town Board held its monthly meeting Tuesday, June 8, 2021 at 6:00 P.M. in Town Hall Shop due to keeping in compliance with COVID-19 virus restriction of social distancing.

Chm. Dupuis opened meeting with Pledge of Allegiance. Present: Chm. Dupuis, Sonesen, Telford, Peterson, and Magnin.

Agenda approved by motion from Telford seconded by Sonesen; motion carried.

Clerk's minutes of May 11 Board of Review meet and adjourn and Town Board Meeting, and May 18 Special Town Board Meeting were read and accepted by motion from Telford seconded by Soneson; motion carried.

May Treasurer's report was given and approved with ending balance of \$218.130.25 by motion from Sonesen seconded by Telford, motion carried.

May bills approved for payment by motion from Sonesen seconded by Telford; motion carried.

Michael and Cherie Bartha, 7616, Co. Rd, I, Oconto Falls, WI 54154, and Paul Shallow appeared before the Board for a rezone and approval of Certified Survey Map. With the LUP Commission recommendation, Telford moved seconded by Sonesen to approve the rezone request for around their house 6.186 acres a combination of AG and R-1 to be rezoned to RR and the leftover be rezoned to AG; motion carried. With the LUP Commission recommendation, Telford moved seconded by Sonesen to approve land division by means of CSM; motion carried.

Paul Monfort, 6802 Tower Drive Rd., Lena, WI 54139 and Paul Shallow appeared before the Board for a rezone and approval of Certified Survey Map. With the LUP Commission recommendation, Sonesen moved seconded by Telford to approve the rezone request on 6.029 acres around the house to be rezoned from AG to RR; motion carried. With LUP Commission recommendation Sonesen moved seconded by Telford to approve the land division by means of a Certified Survey map; motion carried.

Cheryl Braun, 5523 Stiles Rd., Lena appeared before the Board with a petition for a Noise Ordinance due to excessive noise and bright lights on the river below the dam at night. Telford moved seconded by Sonesen for Board to research and craft an ordinance for controlling noise and bright lights during dusk to dawn hours on Oconto River and Machickanee Flowage area and to include all waterways in Town of Stiles. Board vote-3 yes, 0 no; motion carried.

Bids were opened on equipment no longer needed by the town that were in the Recycling Yard. Board approved the following bids: Kurt Delzer-\$262,50 for back blade, Bruce Jeske-\$255.00 for snow plow; Buckfoot Farms, 5770 Olson Rd., Lena, Wi 54139 (phone# 920 373-1675)-\$50.00 for mower deck. There was a tie on the salter which will be rebid in July.

Motion by Telford seconded by Sonesen to have Oconto Co. Hwy. Dept. put up no ATV/UTV signs on Co. I where speed limit exceeds 35 MPH and town cover costs up to \$200.00; Board vote-3 yes, 0 no; motion carried.

Motion by Sonesen seconded by Telford to replace the culvert on St. Patrick's Rd., seconded by Telford; Board Vote-3 yes, 0 no; motion carried.

Motion by Sonesen seconded by Telford to approve Class A and B liquor/beer, cigarette and operators licenses for licensing year 2021-2022; motion carried.

Motion by Telford seconded by Sonesen to switch back to Times Herald as town's official newspaper due to lack of reliability and confirmation of publication of town notices in Oconto Reporter; Board vote-3 yes, 0 no; motion carried.

Motion by Telford seconded by Sonesen for Town Officials to participate in 2021 WTA Spring Town Officials Workshops; motion carried.

Chm. Dupuis gave an update on the partial drawdown to Machickanee Flowage and Oconto Electric Cooperative Public Hearing June 15, 1:00 P.M. at Stiles Town Hall.

Motion by Telford seconded by Sonesen to grant operators licenses to Ashley Plutz, 5221 Husky Lane, Lena & Elizabeth Ann Gomez, 217 N Main St., Apt 3, Oconto Falls; motion carried.

Board of Review dates confirmed--Open Book July 8 and Bd. of Review July 26.

Open question & answer time focused on town roads, ATV routes, and communications.

Motion by Sonesen seconded by Telford to adjourn meeting at 7:50 P.M.; motion carried.
