

STILES TOWN BOARD MONTHLY MEETING – TUESDAY, JULY 13, 2021

Stiles Town Board held its monthly meeting Tuesday July 13, 2021 at 6:00 P.M. in the Town Hall Shop due to keeping in compliance with COVID-19 virus restriction of social distancing.

Present: Chm. Dupuis, Sonesen, Telford, Peterson, and Magnin.

Chm. Dupuis opened meeting with Pledge of Allegiance. Motion by Sonesen seconded by Telford to defer the afterhours noise ordinance to August Meeting; Board vote-3 yes, 0 no; motion carried. Motion by Telford seconded by Sonesen to accept agenda as is; motion carried.

Representatives from Oconto Falls Area Ambulance gave an update on plans for providing health services to the town and the increase costs that would be involved. Chm. Dupuis asked for a motion to suspend Robert Rules of Order so town's people could be involved in the discussion. Robert Rules of Order were suspended by motion from Sonesen seconded by Telford; motion carried. After discussion Sonesen moved to resume Robert Rules of Order, seconded by Telford; Board vote-3 yes, 0 no; motion carried.

Clerk's minutes of June 8 Board Mtg. were read and accepted by motion from Telford seconded by Sonesen ; motion carried.

June Treasurer's report was given and approved with ending balance of \$200,128.26 by motion from Sonesen seconded by Telford; motion carried.

June bills approved for payment by motion from Telford seconded by Sonesen; motion carried.

Motion by Sonesen seconded by Telford to approve the 2021-2022 LP gas contract from Countrystyle Propane, Oconto Falls for contract price of \$1.368; Board vote-3 yes, 0 no; motion carried.

Motion by Sonesen seconded by Telford to defer reconstruction of Crawford Rd. south from Chicken Shack Rd. about 150 yards to bottom of hill and replacement of 2 culverts to August meeting; motion carried.

Motion by Sonesen seconded by Telford to replace east/west culvert on Crawford Rd. which bridge aid will pay half of the cost; motion carried.

Motion by Sonesen seconded by Telford to use money saved from Duame Sand & Gravel's work done on Fredrickson Rd. for work on Fuller Ln.; motion carried.

Motion by Sonesen seconded by Telford to accept Charles Kehl's bid of \$15.37 for the salt spreader; motion carried.

Town Board will do onsite inspection of Koski Salvage Yard Wednesday, August 4, at 7:30 A.M.

Motion by Telford seconded by Sonesen to accept Ordinance# 2021-4 Provisional Operator's Licenses which establishes the standards by which provisional operator's licenses may be issued; motion carried.

The updated Town's Mailbox Replacement Policy was read by Telford with changes made to the policy including requests for inspections of mailbox damage must be made within 48 hours of the damage and putting a limit on reimbursement costs. After discussion, Sonesen moved seconded by Telford to accept the updated Mailbox Replacement Policy; motion carried.

Sonesen discussed Town's web site and use of social media. Town Board is looking to move forward with updating the town's website and for feedback from townspeople to what information and features they would like to see on it.
