

STILES TOWN BOARD MEETING – WEDNESDAY, DECEMBER 8, 2021

Stiles Town Board held its monthly meeting Wednesday, December 8, 2021, at 6:00 P.M. in the Stiles Town Hall. Chairman Dupuis opened the meeting with the Pledge of Allegiance.

Present: Chairman Dupuis, Supervisors Sonesen and Telford, Treasurer Peterson and Clerk Babino.

Chairman Dupuis called the meeting to order at 6:00 P.M.

1. **Approval of Agenda** – Motion by Telford seconded by Sonesen to approve the agenda; motion carried.
2. **Approval of Minutes**
Motion by Telford seconded by Sonesen to change November 10, 2021, board meeting minutes #11 to correct spelling of culverts. Motion by Sonesen seconded by Telford to approve the November 10, 2021, Annual Budget Hearing and Special Town Meeting; motion carried.
3. **Treasurer's Report**
Motion by Sonesen seconded by Telford to approve Treasurer's report with ending balance for November 30, 2021, of \$246,288.74; motion carried.
4. **List of Bills-amend budget if not enough money (if needed)**
Motion by Telford seconded by Sonesen to pay bills presented by Clerk Babino; motion carried.
5. **Rezone 3.047 acres single family at 5395 Pioneer Park Road; Land division of same by means of Certified Survey Map**
Paul Shallow discussed. Motion by Sonesen seconded by Telford to approve rezone of 3.047 acres at 5395 Pioneer Park Road. Motion by Sonesen seconded by Telford to approve land division; motion carried.
6. **Fire contract for Oconto Falls**
Discussion held. Will increase 2% per year. Motion by Telford seconded by Sonesen to approve the fire contract for Oconto Falls; motion carried.
7. **Vote on agreement to sell salt and sand to the Town of Abrams**
Discussion held. Town of Stiles to sell to the Town of Abrams a mixture of salt and sand to be applied to West Slope, Ninebark and Wayfaring Roads. This is approximately 1.9 miles of road. The price is based on the cost of salt and sand, cost of transporting product from Green Bay and mixing time. Clerk will bill Town of Abrams for each application. Chairman Dupuis to bring agreement to the Town of Abrams for their approval at their town board meeting. Motion by Telford seconded by Sonesen to approve and sign the agreement to sell salt and sand to the Town of Abrams; motion carried.
8. **Discuss and vote to sign a letter to be sent to Oconto Parks and Forest and Recreation Division. Petition request to open County Rd 109 and the Iron Walking Bridge to ATV/UTV traffic.**
Chairman Dupuis read letter. Motion by Sonesen seconded by Telford to suspend Robert's Rules of Order requested by townspeople; motion carried. Discussion held. Motion by Sonesen seconded by Telford to resume town board meeting; motion carried. Motion by Sonesen seconded by Telford to approve and sign the letter; motion carried.
9. **Certification of election workers**
Election workers: Jill Babino, Debra Konitzer, Judy Kopczynski, Marilyn Magnin, Jean MaKuck, Sandy Posey and Peggy Sopata. Motion by Telford seconded by Sonesen to approve the appointment of election officials for a two-year term from January 1, 2022 – December 31, 2023; motion carried.
10. **Discussion on noise ordinance**
Supervisor Sonesen gave update. DNR Game Warden Paul Hatrick is now certified to measure decibel levels for noise complaints. Sonesen will give updates as available.
11. **Discussion of Peters Concrete letter of credit RE: Crozier Sand Pit**
Chairman Dupuis read letter from Peters Concrete for irrevocable letter of credit. Discussion held.
12. **Approve operator's licenses** – No licenses requested.
13. **Issue Culvert Permits** – No permits requested.
14. **Correspondence** – No correspondence.
15. **Agenda items needed by January 5, 2022** – Please give agenda items to Chairman Dupuis.
16. **Open question and answer period**
Residents asked questions about ATV/UTV route and Planning Commission.
