WHEREAS, the Town Board of the Town of Stiles has determined that it is prudent that fees be reviewed annually for cost effectiveness; and




Additionally, to the extent that there are any conflicts between this fee schedule and fees contained within any Town of Stiles ordinance or resolution, the fees of this schedule supersede the prior ordinance or resolution and governs.

This fee schedule shall become effective upon its publication and/or posting as required under s. 60.80, Wis. stats.
