## STILES TOWN BOARD MEETING – Wednesday, September 11, 2024

Stiles Town Board held its monthly meeting Wednesday, August 14, 2024, at 6:00 P.M. in the Stiles Town Hall. Supervisor Telford called the meeting to order at 6:00 P.M. and roll call done.

Motion by Sonesen to approve Ordinance O2024-09 for alternate claims/bill pay process, seconded by Telford, motion carried. Tax Refunds update by Gillum, checks out in 15 days, tax bill and tax roll transferred to the county in January. Expense reimbursement – Sonesen. Motion to approve Resolution R2024-05 to approve adopting a policy for expense reimbursement, Motion by Sonesen, seconded by Telford, motion carried. Roads – Telford: Road ordinance will merge with what Bob is working on.

- **17. 6822 Luisier Ln Two Garbage Fees Error** Confirmed mobile home removed in 2017, resident wants records updated and refund for 2018-2024, Motion by Telford to issue refund of \$324, seconded by Sonesen, motion carried

- 19. Ordinances/Resolutions/Permits: Split Shifts for election workers, Fee Schedule NSF, Spec. Assess. Requests, Junk Yard Permit Fee, ROW Permit Motion by Sonesen, seconded by Telford for split shifts for pole workers, motion carried. Amendments to the Fee Scheduled to be made Motion for ROW Permit Fee \$500/\$50 admin fee by Sonesen, seconded by Telford, motion carried; Special Assessment letter fee \$25 Motion by Sonesen, seconded by Telford, motion carried; Junkyard Permit Fee \$75. Raising NSF Fee from \$25 to \$35. Motion by Sonesen to approve Resolution R2024-06 for the Updated fee schedule, motion by Sonesen, seconded by Telford, motion carried.
- **20.** Supervisor Sonesen Upcoming Resignation / Looking for Replacement Supervisor Sonesen will be resigning at some point in the upcoming future, plans are to stay on for the first half of October. A special board meeting will need to be held to hand off her work. Sonesen will remain on the Ambulance for the time being.

Note from Supervisor Sonesen: It has been an honor to serve the Town of Stiles, and I am grateful for the trust you have placed in me. This decision was not made lightly and does not reflect upon the Town, the Board, or any specific circumstances. While I must step down from this position to attend to other priorities in my life, the exact timing of my resignation will depend on finding a suitable replacement and/or developing a successful transition plan. I remain committed to ensuring a smooth handover and will continue to provide support throughout this process.
